

2025 Placerville Arts Association's Plein Air Art Competition
April 26, 2025

- Entries Open:** January 15, 2025
- Deadline for Entry:** The event is open to 25 artists. The deadline will close when 25 artists have entered or on March 30, 2025, whichever occurs first.
- Event Location:** Greenstone Country Barn in the Greenstone Country Community, 3451 Stagecoach Road, Placerville CA. Artists will receive the gate code to Greenstone Country Community and directions to the Barn the day before the event.
- Event Procedure:** After registering and having canvas(es) stamped, artists will receive map and rules for plein air locations within Greenstone Country Community. Artists may drive to other local areas of their own choice, but must return with their completed work to the Greenstone Country Barn no later than 3:30 PM.
- Juror:** Patris, owner of Patris Studio and Art Gallery in Sacramento.

- Entry Fee:** The initial entry fee to participate is \$35.00. Up to three canvases will be stamped by PAA organizers the morning of the event. Only one finished piece may be submitted for judging, unless at the end of the painting time the artist chooses to submit another of the three stamped pieces to be judged for an additional \$10.00 (cash or check). Entry fees are nonrefundable and will be used to cover expenses of the show and reception. - Eligibility:** Placerville Arts Association membership is not required. Open to all plein air artists working in two-dimensional media excluding photography and digital art. Work must be original, created during the event. All canvases or other painting surfaces must be stamped at morning registration. Artwork is to be framed to qualify to be judged and presented for sale. PAA will provide tables for artists to use to frame their work, but artists are to provide their own frames and supplies for framing their pieces.
- Notifications:** Email notifications related to the 2025 Placerville Arts Association's Plein Air Art Competition are sent from placervilleartsassociation@gmail.com and www.entrythingy.com. Please set your spam filter to accept email from these addresses. Be sure to read your letters in their entirety. Acceptance letters may ask you to RSVP or have special instructions for you to follow.
- Sales:** The artist will receive 75% on sales of their work sold during the Artist Reception. Proceeds from artwork sold during the On-Line Show at <https://paa.gallery> will be kept entirely by the artist.
- Liability:** Placerville Arts Association will be diligent in the care of artwork, but is not responsible for loss or damage that might occur. Insurance is the responsibility of the artist.

Day Of Schedule: 9:00-10:00 Registration, Event Instructions, Stamping of canvases
3:30-4:00 Return to Barn to frame art for judging
4:00 Deadline to submit framed artwork for judging
4:00-5:30 Judging and Artist Reception with award presentation by judge and sale of artwork.

On-Line Show: PAA will photograph the entries submitted for judging and publish an online show at <https://www.paa.gallery>. Sales price will be listed online and interested buyers will be directed to contact the artist. Your entry into this event acknowledges that PAA may use images of your art in an online gallery show and for publicity for future PAA events.
